Introduction

PartnerCap Securities, LLC is registered with the Securities and Exchange Commission (SEC) as a broker-dealer and is a member of the Financial Industry Regulatory Authority (FINRA) and the Securities Investor Protection Corporation (SIPC). Brokerage and investment advisory services and fees differ, and that it is important for you to understand these differences. You should carefully consider which types of accounts and services are right for you. We are a registered broker-dealer and do provide our clients with introductions to unregistered securities (private placement securities). This document is provided as a summary of the types of services we provide and how you pay.

What investment services and advice can you provide me?

We make introductions of unregistered securities (private placement securities) to institutional and retail investors. If you provide us information regarding your personal investment goals, holdings and strategies, those services can include considering suitability for investment in private placement securities generally and specifically and making investment recommendations consistent with the information you provide us.

We do not provide on-going monitoring of private placement securities. Also, while we may introduce investments to you, the ultimate investment decision to purchase or not will be yours. Our investment advice covers a limited selection of investments that are usually illiquid.

We generally require retail investors be "Accredited Investors" and/or "Qualified Purchasers" to invest in private placements through us, although in certain circumstances, the sponsor of a private placement investment may waive that requirement. We also offer merger and acquisition services and sponsored research to corporations and institutional clients.

What Fees Will I Pay?

There will be fees and costs (typically paid by the issuer or sponsor) whether you make or lose money on your investments. These fees will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.

If you invest in a private placement security through us, we will receive a transaction-based fee, often called a success fee. While our fees vary, they are not generally negotiable as such fees are usually established by negotiation between the issuer of the private placement securities and us. Some private placement investments impose additional fees that will reduce the value of your investment over time. You should review the related offering documentation for additional information on fees and costs.

What are your legal obligations to me when providing recommendations as my broker-dealer or when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we provide you with a recommendation as your broker-dealer we must act in your best interest and not put our interests ahead of yours. At the same time, the way we make money creates conflicts with your interests.

You should understand how we are compensated because it may create conflicts of interest. We are paid success fees when you invest in private placement securities introduced by us. We may also receive other benefits, such as being offered the opportunity to invest in the securities of the issuer on an advantaged basis or for service as an officer or director of an issuer or an affiliate. We are incentivized to introduce you to securities when we are compensated for doing so.
